# Cambridgeshire Holiday Voucher Scheme - Easter

Cambridgeshire County Council is continuing to run its holiday voucher scheme for the Easter holiday using the Household Support Fund from the Department for Work and Pensions and the additional funding provided by the Council. It was announced in the Autumn Budget that the Household Support Fund will be extended for a further six months and we will provide an update on the future of the Cambridgeshire Holiday Voucher Scheme in due course.

Holiday vouchers will be issued to those families meeting the low-income criteria for the following support:

- Free school meals If your child receives Universal Infant Free School Meals (in Reception, Y1 and Y2) but you do not meet the criteria for Income-Related Free School Meals, you will not be eligible for a supermarket voucher during the holiday period.
- Funded childcare for 2 year olds
- Early Years Pupil Premium
- Students in Sixth Form eligible for Free School Meals (young people aged 16-19)

Appendix 1 of this letter outlines the different income related eligibility criteria based upon children's age. For eligible young people attending Sixth Form Colleges / Further Education establishments, information on how support will be offered will be sent directly by the college.

Details of how to apply for income related Free School Meals can be found <a href="here">here</a> is a <a href="mailto:simple application form">simple application form</a> which only requires a few details for an instant eligibility check. Each successful application will also bring up to £1,500 additional funding for your child's school.

For the Easter holiday, our scheme will operate as follows –

 We will issue each eligible child/young person with a £30 voucher via email and/or text. The voucher will be sent on **Saturday 5 April**. You will be able to choose from a number of different supermarkets.



- Vouchers may take until 9pm on Saturday 5 April to be delivered. If you haven't received your voucher by Sunday 6 April, please contact us. Please include your child/ren's name and their school/ setting in your email.
- Any children who become eligible up until the 20 April 2025 will also receive a voucher. This will be sent when we are notified of newly eligible children by our Education Welfare Benefits Team.
- Details of the supermarkets which will accept the vouchers and how the voucher scheme works can be found in the frequently asked questions document sent with this letter.
- All vouchers must be claimed by 3pm on Friday 9 May 2025. We are unable to reinstate unclaimed vouchers after this date.
- If you **do not** wish to receive the food vouchers, please let your school or setting know as soon as possible so that we can reallocate them.

## Appendix 1 – Eligibility for Direct Voucher Scheme

<u>Parents eligible for Funded Childcare and Education for 2-year-olds</u> under the income-based criteria (children aged 2)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance (JSA)
- Income-related Employment and Support Allowance (ESA)
- Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments
- Tax credits, and your household income is £16,190 a year or less before tax
- The guaranteed element of Pension Credit
- The Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)

Parents eligible for Early Years Pupil Premium under the incomebased criteria (children aged 3 and 4)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based <u>Jobseeker's Allowance</u>
- Income-related Employment and Support Allowance
- Support under part six of the Immigration and Asylum Act 1999
- The guaranteed element of <u>State Pension Credit</u>
- <u>Child Tax Credit</u> (provided you are not also entitled to <u>Working Tax Credit</u>) and have an annual gross income of no more than £16,190
- Working Tax Credit run-on, which is paid for 4 weeks after you stop qualifying for Working Tax Credit

 Universal Credit - your household income must be less than £7,400 a year after tax not including any benefits you get

# Parents eligible for Free School Meals (children and young people aged 4 to 16)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you applied on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

Children who get paid these benefits directly, instead of through a parent or guardian, can also get Free School Meals.

If your child receives Universal Infant Free School Meals (in Reception, Y1 and Y2) but you do not meet the criteria for Income-Related Free School Meals, you will not be eligible for a supermarket voucher during the holiday period.

### Eligible for 16-19 Free School Meals

To be eligible for a free school meal, students must be enrolled in Further Education provision funded by the Education Skills Funding Agency, aged over 16 but under 19 on 31 August 2024 and be in receipt of, or have parents who are in receipt of, one or more of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance (ESA)
- support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit (provided they are not entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by Her Majesty's Revenue and Customs (HMRC))
- Working Tax Credit run-on paid for 4 weeks after someone stops qualifying for Working Tax Credit
- Universal Credit with net earnings not exceeding the equivalent of £7,400 per annum (after tax and not including any benefits you get)

# Other Eligibility

Children in care are not covered by the scheme as the costs of meals in the holidays are covered by fostering allowances.

Students aged 16 or over but under 19 on 31 August 2024 and accessing the bursary scheme.

Students aged 19-25 who have an Education, Health and Care Plan and access the bursary scheme or free school meals at college.

### How to Claim Free School Meals

We understand that families continue to live in uncertain times, and many are facing changes to their financial circumstances as a result. If you have not previously applied for Free School Meals, or your name has recently changed, and feel you now meet the criteria below, please visit <a href="https://www.cambridgeshire.gov.uk/freeschoolmeals">www.cambridgeshire.gov.uk/freeschoolmeals</a> to apply online;

- Income Support.
- Income-based Job Seeker's Allowance.
- Income-related Employment and Support Allowance.
- Child Tax Credit but no element of Working Tax Credit and have an annual income (as assessed by HM Revenue and Customs (HMRC)) that does not exceed £16,190.
- If you are supported under Part VI of the Immigration and Asylum Act 1999.
- Guaranteed element of State Pension Credit.
- Working Tax Credit during the four-week period immediately after your employment finishes or after you start to work fewer hours per week.
- Universal Credit with an annual net earned income of no more than £7,400.
